Charges per call will be commenced at each call connection and ends at termination of that call. Calls are rated based on the commencement of the call. Charges are calculated using multiples of six-seconds. The minimum duration or minimum charge per call is six-seconds. A Customer whose charges for the One2One internationalcard Service for the month exceeds eight hundred and fifty Hong Kong dollars (HK\$850.00) will automatically receive a five per cent (5%) discount on the charges for that month. The charges will be debited to the Customer's nominated credit card.

In order to access the One2One internationalcard Service, a caller must be registered with WTT as a holder of one or more One2One internationalcard. To become a registered holder of one or more One2One internationalcard, an application form must be completed and returned to WTT together with the required documentation. Applications will be approved at the sole discretion of WTT.

The following Special Conditions shall apply:

a. Application

For the purpose of this service unless the context requires otherwise:

- * "WTT" means WTT HK Limited,
- * "Card" means the One2One internationalcard issued by WTT,
- * "Customer(s)" means person(s) who is registered as holder of the Card,
- * "Services" means the telecommunications services offered by WTT and accessed through the use of the Card, and
- * "Conditions" means the Special Conditions set out in this section.

b. Use of the Card

When WTT accepts an application for the Card it will issue a Card and a Personal Identification Number (PIN) to the Customer. The Customer will not disclose the Card number and PIN to any person except as 4uthorized by WTT. WTT may change any account number, PIN or any other code, number or name allocated by WTT from time to time to the Customer for use in connection with the Card.

The Card will be valid for use from the validity date until the expiry date notified by WTT to the Customer. Use of the Card constitutes understanding and acceptance of these Conditions.

WTT remains the owner of the Card at all times. The Customer must immediately return the Card when WTT requests its return. WTT may demand the return of the Card if the Services is suspended or terminated.

The Customer must notify WTT of the loss, theft or misuse of the Card. The Customer will be liable for all charges arising from using the Card until the Customer has notified WTT of the loss, theft or misuse.

c. Charges and Payment of Charges

The charges for Services are as set out in WTT's Tariff for the Services and are subject to change without prior notice to the Customer.

All charges for the Services will be charged directly to the Customer's nominated credit card account. In certain circumstances the Customer may be asked and will provide WTT a deposit or advance payment in order to secure the charges WTT requires to be secured.

d. Suspension or Termination

WTT may suspend or terminate the provision of Services to the Customer and invalidate the ard if any credit card nominated by the Customer has been canceled, expired, lost or charges for Services is rejected by the issuing bank of the credit card or if the Customer is in breach of any of these Conditions. The Customer will inform WTT if the nominated credit card is lost, canceled or expired. The Customer may at any time terminate the Services by informing WTT in writing.

e. Liability

The Customer acknowledges that the Services may be temporarily suspended or interrupted due to circumstances beyond the reasonable control of WTT, including without limitation, limitations in the network or system, or maintenance or modification of such network or system. WTT will not be liable to the Customer in the event of such suspension or interruption of Services.

To the extent permitted by law WTT will not be liable to the Customer or any third party for any losses or damages arising out of any act or omission of WTT, whether negligent or otherwise.

f. Miscellaneous

The Customer will notify WTT of any change of address or any particulars provided to WTT which may affect the provision of Services to the Customer.
