**WTT HK Limited (“WTT”)**

**14. WTT Phone Card**

Effective date: 17/2/97, Revision date: 28/2/97, 1/1/99, 1/11/99, 13/4/00, 7/7/00, 1/5/06  
(This Service will not be offered to new customers from 2013 onwards)

WTT Phone Card (the “Card”) is a fixed stored value calling card which enables the Customer to make IDD calls from Hong Kong. WTT may, from time to time, issue special edition of the Card or Card for calling to specified destination(s) only. The purchase price and calling value of the Card will be as specified by WTT or as printed or embossed on the Card. Unless otherwise specified in the particular edition or issue of the Card, destinations and calling rates are as per WTT’s IDD001 service. All call charges for services provided through the Card are on per minute basis. The following are destinations which rates are different from WTT’s IDD001 service:

The Home Direct feature is available in respect of calls to Hong Kong from those countries denoted \* in the above. Charges for the Home Direct from the relevant country will be equivalent to WTT's IDD 001 rates for outgoing call from Hong Kong to such country as tariffed.

Third Country Calling feature enables Customers to call from a country specified in the Home Direct to any of the destination countries for outgoing calls from Hong Kong. The rate of charges will be the aggregate of the charges for calls on Home Direct and calls from Hong Kong to the destination country.

The Third Country Calling feature is accordingly now available from the countries specified in the Home Direct (except for such countries denoted \* above) to selected destinations for outgoing calls from Hong Kong. The rate of charges will be the aggregate of the charges for calls on Home Direct and calls from Hong Kong to the destination country as tariffed.

WTT Phone Card service may be used to make local calls, and the applicable charge shall be \$1.00 per 3 minutes (minimum charge of 3 minutes per call) and every incremental 3 minutes thereafter.

The following Special Conditions shall apply:

- (a) When WTT accepts an application for the Card it will issue a Card, Card or account number and a Personal Identification Number (PIN) to the Customer. The Customer will be responsible for the security of the Card, account number and PIN.
- (b) The Card will be valid for use from the validity date until the expiry date notified by WTT to the Customer or when the residual calling value is zero or is insufficient to make a call. The Card and the service provided therein are subject to WTT's General Terms and Conditions of Service and the relevant Tariff including these Special Conditions and use of the Card constitutes understanding and acceptance thereof.
- (c) The Customer shall be responsible for the safe custody of the Card. The Customer may notify WTT of the loss, theft or misuse of the Card and request for cancellation or suspension of the service provided through the Card. WTT may, at its sole discretion, refund the Customer the amount equal to the residual calling value of the Card.
