# UNIFIED CARRIER LICENCE TELECOMMUNICATIONS ORDINANCE (Chapter 106)

## WTT HK LIMITED ("WTT")

### O. GLOBAL CONFERENCING SERVICES

Effective date: 9/10/97, Revision date: 1/3/99, 1/8/99, 17/8/99, 1/11/99

Global Conferencing service provides audio conferencing service for domestic and international use in selected countries.

#### Optional features:

- (a) Conference recording a recording of the audio conference on a standard 90 minute audio cassette tape is provided.
- (b) Instant replay a fully automated conference playback service available 24 hours a day. This service may be accessed by dialling a Hong Kong number and then entering a security code.

#### Charges:

The charges for Global Conferencing comprises the Service Charge, and when applicable, the Dial-Out Charge, both of which are based on the actual duration of the audio conference. Charges are on a per line, per minute basis.

- (a) (i) Service Charge (operator assisted conferencing) covers the provision of conference service management which includes all functions performed during a conference call, including, without limitation, connection, roll call, on-line troubleshooting, announcing late participants, breakdown of large conferences into smaller groups, and adding participants at any time.
  - (ii) Service Charge (automated conferencing) no operator assistance.

(b) Dial-Out Charge - applies when the Customer elects for WTT's Global Conferencing centre to co-ordinate the dialling-out of participants to a conference. This charge varies according to the location of the conference participants. Customers are charged to the nearest minute.
