P. IP CONNECT NETWORK SERVICES

IP Connect Network Service is a public managed Internet Protocol (IP) data network in Hong Kong which provides services for data communications and networking. This Service allows customer to provide remote access service by leased circuits* access and dial-up access for users to their host network. Typical applications include Bulletin Board Access, Database Access, Electronic mail, Electronic File Transfer.

Service options available:

- (a) IP Logical Session Subscription which provides a fixed number of logical sessions to be available to the endusers of the Customer. Customer must subscribe to a minimum of 10 sessions; and
- (b) IP Network Value Added service which provides, at the request of Customer:
 - (i) Packet throughput report which is a monthly report providing the Customer with a breakdown of host link traffic and utilisation; and/or
 - (ii) User session report which is a monthly report providing the Customer with a breakdown of their enduser access patterns.
- (c) User Profile Management a management services feature. Customers will provide the end-users' database to WTT, and WTT will supply management services including end-user profile registration, and user authentication.
- (d) Private Link provides a secure and private connection between the network access server and Customer's network. All information flow between these two end-points will be encapsulated and can only be put into the network and be readable from the network at these two end-points.
- (e) Usage Detail Record Reporting available for subscribers of User Profile Management feature, which provides the Customer with the end-user access record which the Customer can use for billing purposes.

The following Special Conditions shall apply:

- (a) First level/direct support for Customer's end-users shall be the responsibility of the Customer.
- (b) In relation to Customers other than subscribers to User Profile Management feature, security, administration and registration shall remain the responsibility of the Customer and the Customer will require a RADIUS security server for their end-user authentication.
- (c) Billing of individual end-users will be the responsibility of the Customer.
- (d) In relation to Customers other than subscribers to Private Link feature, the Customer is responsible for providing valid registered IP addresses for use with the Service.

- (e) The Customer is responsible for the provision, development, maintenance and support of all Domain Name Server, proxy servers, mail servers, applications, and all ancillary equipment, hardware and software, and facilities or services relevant to servicing their end-users.
- (f) Minimum contract or subscription period for this Service is 3 months.
- (g) In relation to PNETS operators, the Customer warrants that it holds a valid PNETS licence and that it will act in full compliance of its PNETS licence. The Customer shall indemnify WTT for any losses or damages as may be suffered by WTT as a result of a breach by the Customer of its PNETS licence.
- (h) Where usage charges apply, occupancy minutes refers to the time between the seizure of a circuit and the release of the circuit.
- (i) The Customer shall be liable, to the exclusion of WTT, for any applicable Universal Service Contribution payable for use of the Public Switched Telephone Network.
- (j) Any usage charges for this Service exclude any applicable PNETS charges.

Access Panel Service comprises a front-end panel interface which allows end-users of the Customer to access their IP (Internet Protocol) host data network through the IP Connect Network.
