## T. MISCELLANEOUS SERVICES AND CHARGES

#### T1. Call Charges

Effective date: 24/12/97, Revision date: 1/1/99

The following charges are based on usage:

### T2. Number Change Service

Effective date: 11/04/03

Number Change service provides the changing of Directory Number allocated by WTT to the Customer at the request of the Customer. The charge for this service is \$200.00 per number change.

## T3. After Hours Charges

In addition to the basic charges, after hours charges will apply for services undertaken outside WTT's Standard Business Hours:

### T4. Integration Services

WTT may, at the request of the Customer, source for the Customer certain telecommunication services provided by a third party supplier at the supplier's list price as published. Service levels and minimum subscription periods for these services will be as set by the supplier. The charges payable by the Customer to WTT for these services will be an amount which is the aggregate of the supplier's published list price plus the list price multiplied by a factor of 35%. This Service includes WTT's previous T1 Integration Service.

### T5. Customised Music On Hold

Effective date: 17/2/97

This service enables Customers of Centrex service to have their specified music or message ("Message") played to their callers while they are being put on hold.

The following Special Conditions shall apply:

(a) The Customer shall obtain all relevant permission or authorisation to play their specified Message. The Customer shall immediately notify WTT if any permission or authorisation to play the Message is suspended, withdrawn or terminated for whatever reasons. (b) The Customer shall hold WTT harmless against any claims for losses or damages arising from the broadcasting of the Message, or any claims by a third party for infringement of any rights subsisting in the Message (including intellectual property rights).

#### T6. Change Number Announcement Service

Effective date: 24/12/97

Change Number Announcement (CNA) service is available to Customers who change to WTT as their telecommunication provider and adopt a WTT directory number. With CNA, callers to the Customer's former directory number will hear an announcement that the dialled number is not available and the caller will be advised of the new number to call.

#### T7. Dual Access Service

Effective date: 15/5/99

Dual Access Service (DAS) is available to Customers who change to WTT as their telecommunication provider and adopt a WTT directory number. With DAS, all calls to the Customer's former number will be forwarded to the new directory number, enabling the Customer to be contacted through both former and new directory numbers.
